Our Night Watch opportunity in Northern N.J. is one of the few in the country that is that is totally organized by recovering alcoholics. I have been fortunate to have been involved in bringing meetings into Morris County Jail for the past eight years, and a member of the CFC (Corrections Facilities Committee) for the last four of those eight years. When reviewing my experience regarding this particular service effort, our Three Legacies come to mind, Recovery, Unity and Service. Each of these guiding principles are well represented in Corrections work. When speaking about recovery in service work, we usually refer to the people that we are doing service work on behalf of. For example, there are men in my Home Group that visit male inmates in jail to take them through the steps. Recently I was asked to provide some Step 4 Work Sheets for the inmates to use. I later heard from one of the volunteers saying how the inmate he visits had filled out his work sheets and was ready to do Step 5. To learn of someone embracing the program and taking an active role in his recovery was very rewarding to be a part of. But the recovery doesn't stop there. In my participation of bringing meetings into jail my recovery is strengthened. Just reading from the Big Book and sharing my experience, strength and hope with the inmates, I feel a sense of usefulness that reminds me that this work is necessary for my recovery as well as theirs. I recently spoke with a person who wants to get involved with our committee and bring meetings into a facility. When speaking to

him I could hear the enthusiasm in his voice. He finished our conversation saying "I need this commitment!". Wow! I understood that he felt this work was vital to maintain and grow his sobriety. The principle of unity displays itself in so many ways. At our bi-monthly CFC meetings we have approximately 30 volunteers in attendance. We share what is going on in our respective facilities, situations, ideas, challenges and successes. This is also a great opportunity to get to know one another. Each member is a great resource to the others. Both in the CFC and the ACM (Area Committee Meeting) I have met so many truly humble and grateful members of our fellowship. Their devotion to help the sick and suffering alcoholic is inspiring. When I hear the phrase "Stick close to the winners" I believe I have found them. When it comes to the principle of unity there is no better example than the "Pink Can" donations. The overwhelming generosity of our members to donate money for the purpose of supplying A.A. approved and Grapevine literature to inmates in jails and prisons is simply amazing. I am humbled and grateful to be able to see this act of kindness first hand. A.A. members thinking of those that are locked up, afflicted with this condition and providing them with the tools to achieve sobriety is a wonderful thing to be a part of.

Regarding our legacy of service, I refer to a quote from Working With Others "Helping others is the foundation stone of your recovery". There are many ways to serve in regards to Corrections

work.

Corrections Correspondence – Share your experience, strength and hope with an inmate in another part of the country via writing letters.

Pre-Release Request – Volunteer to escort a recently released prisoner that has relocated to your area to local A.A. meetings until they get situated with a sponsor. Assume the role of District Corrections Chair and visit the groups in your district. Ask if they would consider supporting the "Pink Can" for donations to purchase literature for inmates in local jails and prisons.

And last but not least, bring A.A. meetings and literature into correctional facilities. This is our greatest need and the core of what we do.

Service is extremely important to my sobriety, but is by no means the sole ingredient to my recovery. I need to be aware and participate in all three of our legacies: Recovery, Unity and Service in order to lead a useful, happy and sober life. Being a part of the Corrections Committee these past four years has been a great experience. I hope if you want or need to do some service work outside of your immediate Home Group, you will consider the Corrections Committee or any of the other many important service committees that we have in Area 44.



Take two... done. Thank you for this opportunity.

It is a miracle that I don't drink (or use and abuse other substances...) any more. It is a miracle, but no accident. Using and abusing was the only tool in my tool box; to celebrate, relax, avoid, escape, find some relief, or at times, just get out of bed. The program and fellowship of AA taught me how to live life on life's terms, gave me new tools to live by and a new outlook on life.

The Big Book says alcohol is cunning baffling and powerful. I don't know that alcohol is all that, after all, it is just a beverage, in a bottle or glass. What is undeniably powerful in my life is the -ISM of alcoholism: the disease, the mental obsession, the allergy, the mental, emotional, physical and spiritual damage of my addictions. Thankfully, by the grace of G-d, while I learned there was a progression to my disease, there has been and continues to be a progression to my recovery.

I recall early in recovery, sitting next to a guy who, every once in a while, would elbow me in the ribs and say "hear that, that's untreated alcoholism" Noting, some guy, who hasn't had a drink in a while (maybe years), telling the same stories; losing another job, getting into another fight, getting arrested...again. Untreated alcoholism, doesn't matter the details, we are doomed to repeat the past if we don't change. The Big Book says we have a daily reprieve contingent on the maintenance of our spiritual condition. AA continues to provide me the opportunity to change.

of sobriety, emotional sobriety. There are days when I follow the basic suggestions of the program. Those days tend to be more happy joyous and free than not. More loving, tolerant and of service... There too are days when I am more restless, irritable and discontent (again a quote from the Big Book), when I still feel sick and suffering. Today, my sickness is mostly between my ears and in how I treat myself and others. As we say, I came for my drinking and stayed for my thinking.

The rooms and fellowship are where I received my formal education. The Big Book, 12 and 12 and other literature are the textbooks for living a sober life, and the step work and service became the curriculum by which my life changed. It is easy to stay clean in the rooms for an hour, but as a newcomer, I struggled to not drink or get high for the other 23 hours a day. Now, as I was told long ago, each day is a new opportunity. There are times when "I have enough sober perspective to know what I need to do", and times when I have "no sober experience" to deal with what comes my way. Sometimes I carry the message and sometime I am the one who is still sick and suffering. Today, the -ISM remains cunning, baffling and powerful. That -ISM can take many forms. Looking at the miracle that is my life today, I am also reminded that the progression of my recovery continues to manifest itself in new ways and new opportunities. In general, I have learned the more active a participant I am in our program of recovery, the healthier and more consistently sober my life becomes.

The Truth Set Me Free

I goofed when I wrote the appointment on my calendar. I don't remember when the little fibs grew into bold-faced lies but I do remember getting caught – and not caring. Or thinking I didn't care. Or trying to convince myself I did not care. For me the truth was very fluid in so many ways. Somehow in early recovery I was stunned to realize how skilled a liar I had become. I easily accepted the truth that I was an alcoholic and that a power greater than myself could – and would – take away my obsession. But I choked again and again on the part about "grasping and developing a manner of living which demands rigorous honesty." And I relapsed three times.

Was I open and honest about my relapses? Hardly. But I kept going to meetings, kept listening, kept asking questions. My sponsor fired me. I searched for a new one, one who could help me find my way to the happy road of destiny. Before I found a sponsor, I found my higher power. I began chatting with Him first thing every morning. And sometimes, last thing at night. I never did "hit my knees," as many in the fellowship had suggested. I simply grabbed my first cup of coffee of the day and went outside with my dog and started yacking out loud. A kind friend outside of the rooms suggested I begin my conversation with an affirmation: "I am good. I am worthy of all the wonderful things you send my way." This always led to a list that continued well after the coffee was gone and my dog was ready for his breakfast. The morning after my third (and, hopefully, final) relapse, I nearly choked on the words "I am good." I knew God loved me regardless of my flaws but I could not bear to say those words to him out loud. I simply could not lie to God. And it dawned on me: I no longer wanted to lie to myself. Was there magic in that moment? Sort of. It was more of an "Ah!" moment than an "Aha!" moment. There was peace, but there was still a lot of work to be done. There's always work to be done. My work on honesty continues more or less on its own. The smallest fib - even just the tiniest germ of a not-yet-formed fib - now triggers an honest conversation with God or myself. I've found my sponsor - or, more likely, God found her for me. I now engage in "God talk" freely, not just alone in my back yard but with others. By turning my life over to the care of God, I'm enjoying a new kind of freedom, Continued on page 5

Humbled to Serve, Marybeth A. 2018 Convention Chair

Over time, my language has changed too. I say the date of my last drink was... and that I am sober today. It's just not a nuance of language, it's a statement of fact about my understanding I was raised by people who believed that honesty is the best policy. Or at least that lying is a bad thing to do.

As a child, I never got away with a fib; as a teenager, I learned how quickly I could get caught in a lie. Keeping a lie alive required a very good memory and creative embellishing. Clearly it was easier to simply stick to the truth. Those values vanished when I drank. At first, I was fairly clever covering up my bad habit. And at first my little fibs were believable: I hadn't eaten all day; I slept poorly; I was coming down with something; it was an allergic reaction; I didn't hear the phone;

I'm still studying steps one, two and three, still amused that I accomplished them out of order. And with my one-year anniversary less than 10 weeks away, I'm still amazed that the 12 promises do come true.

The Three Legacies: Recovery – Unity – Service.

Every one of my six coins includes these three words and a dot in the middle, representing the individual. I am just a small dot, just one, a worker among workers and certainly not running the show. The flip side is that I do have a place: on the coin, in AA and in the world. Part of my journey through life as a sober woman is finding that place; on the beam, balanced and right sized. I am not everything, but I'm not nothing either.

We recover through the AA program, we form relationships and bonds with other AAs through sponsorship and fellowship which is unity and then there is service: giving back.

Service opportunities are all around us; from one on one, meetings, our home groups, in the district and area. I have served in many ways in the time that I have been coming to AA. It is how I was taught and it is part of what I pass along when I carry the message.

Recently, I turned over the GSR role to another group member to become DCM for District 32 (Bayonne). Not having the benefit of serving as the alternate DCM, I was filled with fear. I was afraid of change, commitment, the time needed to serve, afraid of failing, of doing well, afraid of what people would think of me, good or bad, afraid of my ego or my confidence being crushed. You name it, I was afraid of it. Encouraged by my sponsor, I faced these fears and accepted the opportunity to help bring a nearly dark district back to the light. I began to attend more than just my regular meetings and groups in the district to urge folks to get involved. I reached out to those AAs who had been involved in the past, connected with former DCMs and the current DCMs for the two neighboring districts and attended an ACM meeting for the first time, all within the first month. Sounds like a lot of effort however, in reality, I made some

phone calls, exchanged a bunch of texts, attended a few extra meetings and spent one Sunday morning in South Plainfield. I didn't have to quit my job nor put life on hold. Currently, we have a DCM, an alternative DCM, nine GSRs, two alternate GSRs and a potential PI representative. The District held the annual picnic in August, but this was not without a few bumps in the road. The picnic venue and date were changed late in the game and a few controversial issues regarding district procedure popped up. However, time and time again, I did what the program teaches. I did the next right thing and these situations were managed and handled. Answers came when I stopped, listened and waited for them and God's plan turned out better than I could have expected. The issues will be worked out with little or no drama and we as a district will be better for it. After leading the meeting at the picnic in August, a woman with a few days sober pulled me aside for a moment to tell me what I said really inspired her. I spoke of the life beyond my wildest dreams that I live today which is filled with serenity, peace of mind, loving myself and others, confidence, humility, strength, gratitude and

more. I urged those who are struggling or new to not leave before the miracle happens. Everyone's effort, time and energy were worth that moment when one alcoholic helped another. If one seed can be planted, one life might be saved then it's worth it all. This is what service means to me and the reason why I am touched every time a read the Responsibility Statement.

All of this is hardly my doing alone. I simply

ing less of ourselves but thinking of ourselves less.

Many a speaker has shared from the podium that they "can never repay AA". I thought I knew what that meant as it seemed obvious. However, since I have served as DCM, I began to experience the true meaning of that statement. Through the people and program of AA, I got sober and life changed in the most beautiful ways. There is the "debt" that I owed right there. When I perform any service in AA to "give back" in an effort to repay this debt, I gain so much and grow in my own sobriety that the debt keeps growing. Therefore, the more I "pay", the more I "owe". On a final note, District 32 is looking forward to hosting GSR/ DCM workshop on October 6th which is a great opportunity to learn how service can make a difference.

It's further proof that your way doesn't work.


